Textual Information()	<p>It is to be noted that Mr. Rohit Pandey and Mr. Sunil Dutt Pandey (New Promoters) entered into Share Purchase Agreement dated May 03, 2024 and also completed the process of Open Offer as per SEBI SAST Regulations. Therefore, pursuant to Share Purchase Agreement and open Offer, the Old Promoters and Promoter Group of the Company have sold their shares to New Promoter. The Open Offer was opened on July 12, 2024 and closed on July 26, 2024. As per Letter of Offer, upon completion of Open Offer, the Old Promoters and Promoter Group of the Company do not remain promoters of this Company. However, out of total 30 (Thirty) Old Promoters and Promoter Group of the Company, the 4 (four) Promoter Group relating to Old Promoters are still under process to transfer all their shares to New Promoter. As the transfer of shares of those 4(four) Old Promoter Group are under process of transfer, therefore, we are showing the names and holding of those 4 (four) Old Promoter Group in this shareholding pattern. Once all the shares of these 4 (four) Old Promoter Group will be transferred to New Promoter, their names will be removed from the Promoters and Promoter Group category and automatically be reflected under Public Shareholders category.</p>
